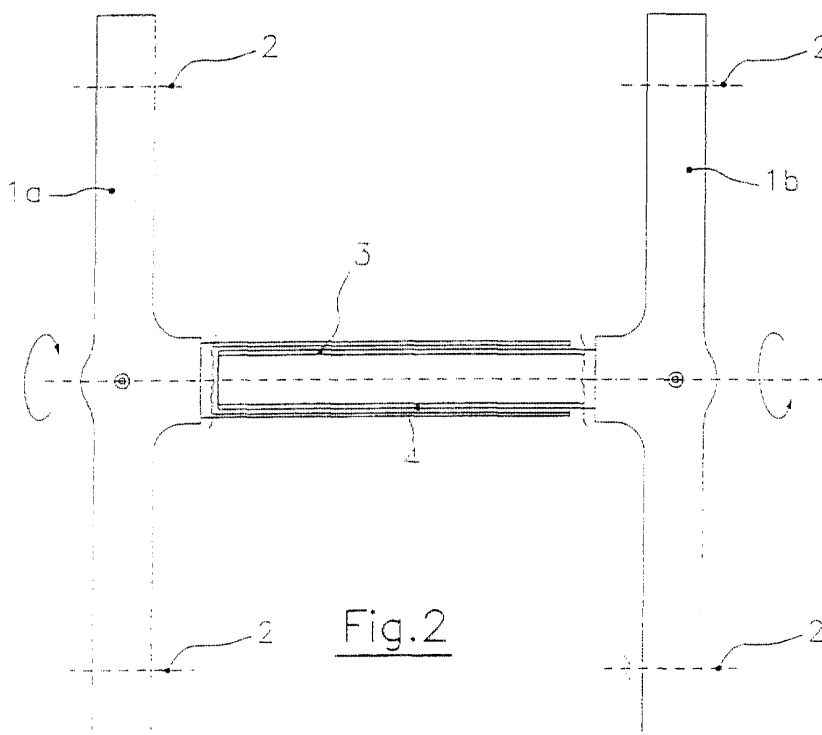

(54) **Hinged bogie for rail vehicles**

(57) An hinged bogie for rail vehicles comprising two longitudinal members (1a, 1b) supporting the wheels (2) and two tubular transverse shafts (3,4) each extending

from one of the two longitudinal members. Transverse shafts axially and pivotally engage with each other and means for locking (20) the mutual axial sliding thereof are provided.
