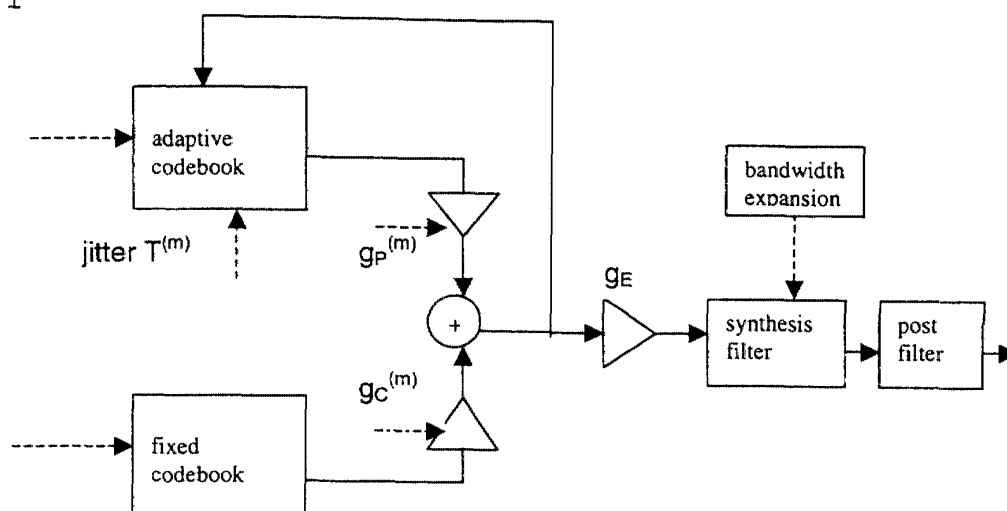

(57) A decoder for code excited LP encoded frames with both adaptive and fixed codebooks; erased frame

concealment uses muted repetitive excitation, threshold-adapted bandwidth expanded repetitive synthesis filter, and jittered repetitive pitch lag.
