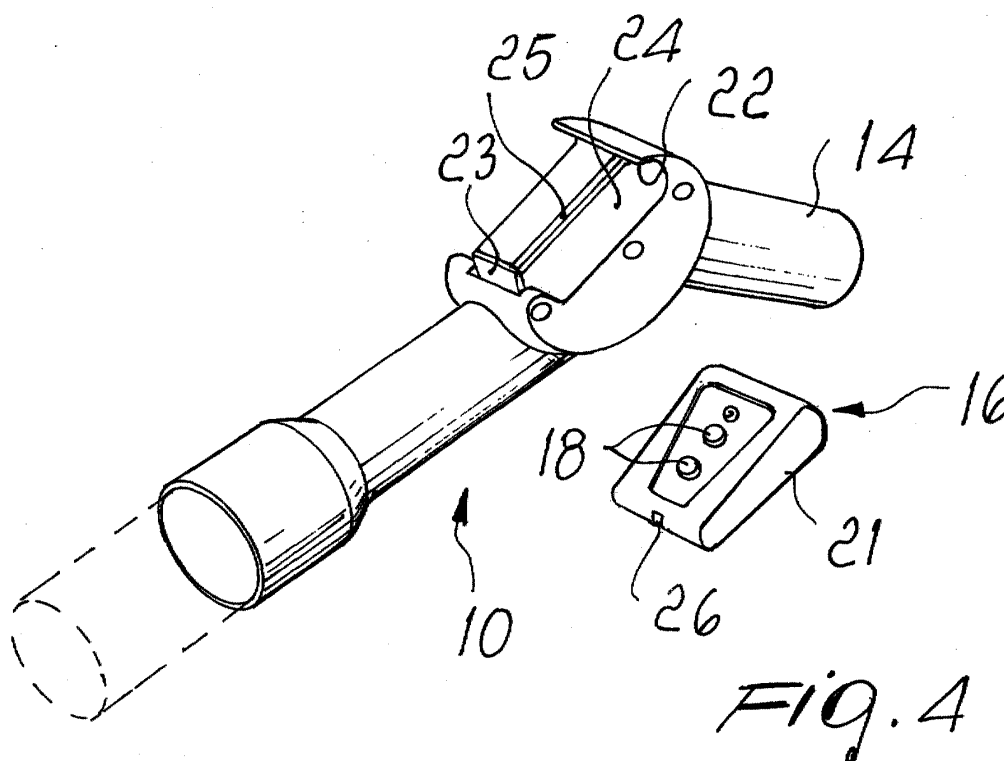

(54) **Control device, particularly for cleaning appliances**

(57) A control device, particularly for appliances used in the field of domestic and/or industrial cleaning, comprising at least one signal transmitter (16) which is

removably located on the handle (14) of the tool of the cleaning appliance and a receiver which is located on the appliance body and is connected to means for controlling the various functions of the appliance.
