shape of the playing piece determining the movement of the projectile when the projectile is hit by the playing piece.

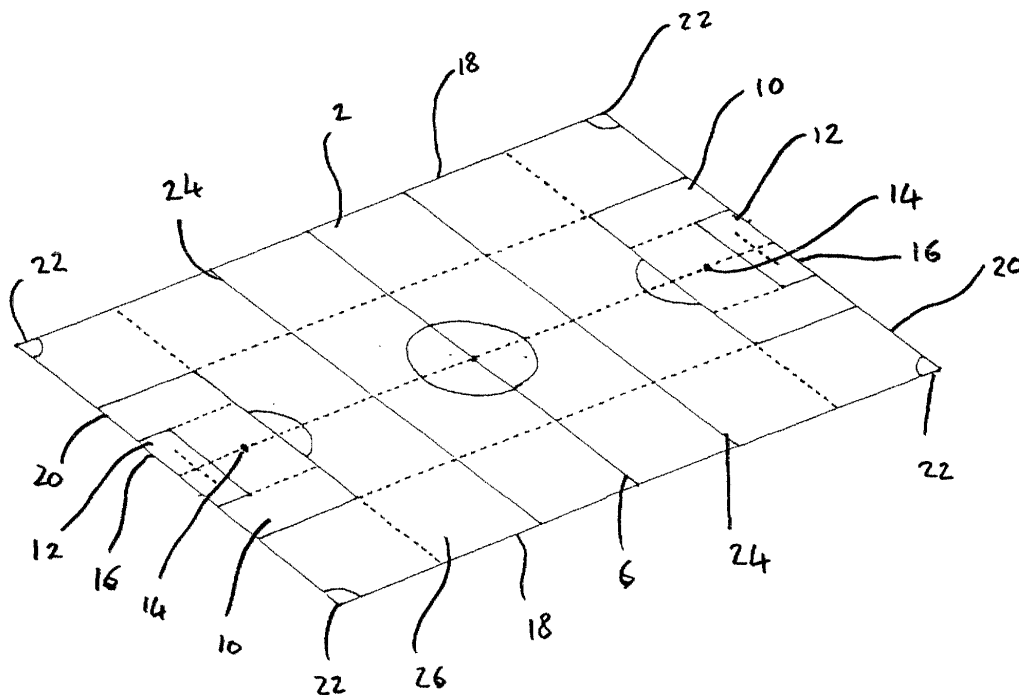
