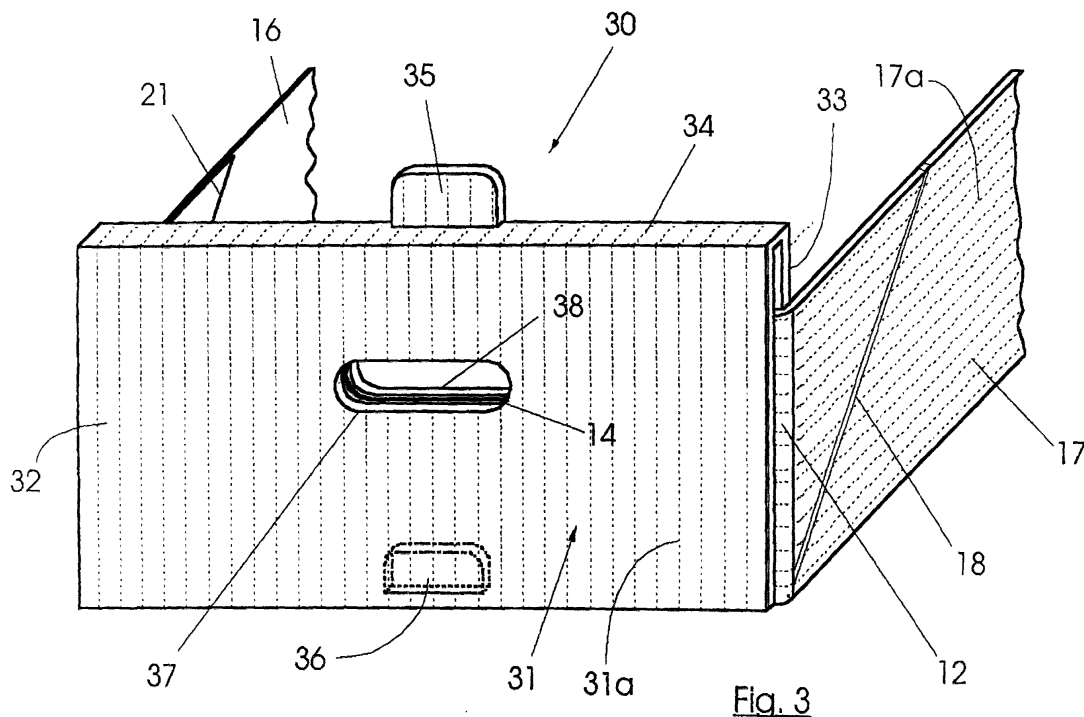

(54) **Foldable and recyclable box made of corrugated board**

(57) A box (30) for packaging and/or transporting and/or storing products comprises a structure (10) foldable on sides (18,19,20,21) entirely made of corrugated card-board; said structure comprising a base or bottom

(11), a pair of larger side walls (16,17) and a pair of smaller side walls (12,13); furthermore, it comprises a pair of reinforcing and supporting elements (31,40) made of corrugated board which are joined to a pair of opposed side walls belonging to said structure.
