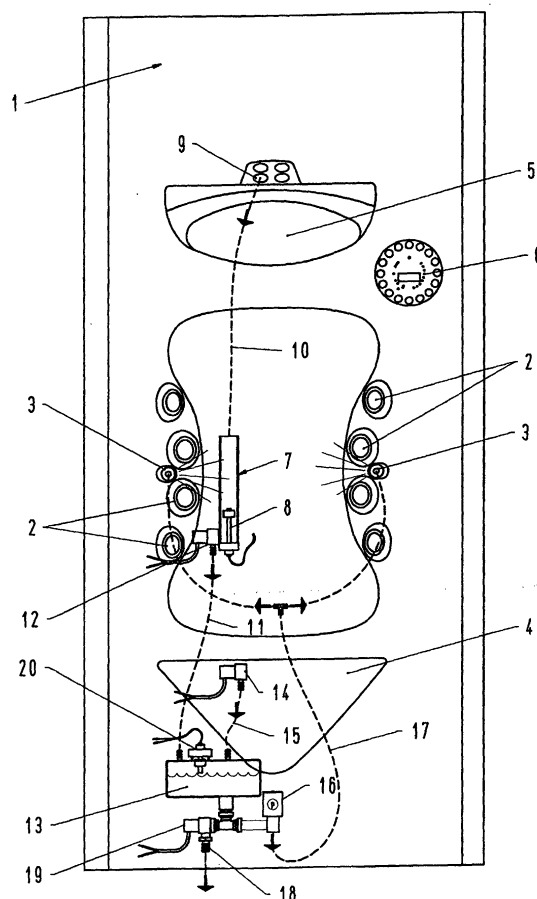

(54) **Hydraulic system for the metered delivery of additive products in a sanitary apparatus**

(57) A measuring container (13) receives from a reservoir (7) and the water mains respective amounts of aromatising oil and water so as to instantly prepare a metered and homogeneous mixture, with which an atomising nozzle (3) is then supplied.
