(54) **System for cleaning a ship side**

(57) The invention relates to a pump unit (1) and a cleaning head (2) connected to the pump unit (1), for cleaning a ship side (4) of a ship which is placed on a wharf or in a dry-dock (5). During cleaning, the cleaning

head (2) is manually moved back and forth along the ship side (4), while the pump unit (1) supplies the cleaning liquid under high pressure and at the same time drains away cleaning liquid with fouling, removed from the ship side.

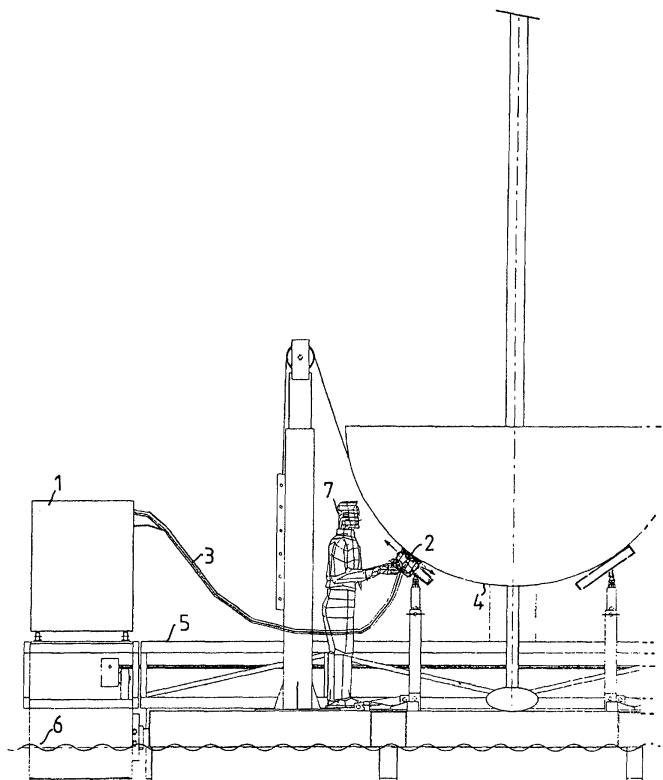
