

(54) Device for the hanging and support of roller blinds

(57) A device comprising a pair of supports (4) associated with the respective longitudinally opposed ends of a roller (2) for blinds is described; each support (4) includes a hanger (5) for fixing to a wall and a bracket body (6) which can be restrained on the hanger (5) and

includes a cheek (7) and a rear element (8), the cheek (7) and the rear element (8) being provided with mutual fixing means such that the cheek (7) can be fixed alternatively to one or, turned through 180°, to the other of the opposed sides (8a, 8b) of the rear element.
