(54) Lamp holder (socket) with nut

(57) Lamp holder (socket) with nut used for internal and external lighting and is manufactured according to the international standards on non-assembly after its integration with the electricity cable.
The lamp holder (socket) (1) is comprised of the main body (1a), the lamp (3), the electricity cable (2), the cover (4), the spikes (5a), the waterproof flange (6), the bolts (7) and the verge (11).


