- (54) Apparatus for spraying liquids, and disposable containers and liners suitable for use therewith
- (57)A reservoir (40) for a gravity feed spray gun comprises a container (41) and a removable lid (42) arranged to close an opening in the container (41) and provided with an outlet for transferring liquid from the reservoir (40) to an inlet of the spray gun during operation of the spray gun. A base of the container (41) is provided with an air hole (44) that can be closed when required. The reservoir (40) is provided with a filter (45) arranged to filter liquid withdrawn from the reservoir (40) through the outlet in the lid (42). The filter (45) may be located in the lid (42) and a range of filters (45) having different mesh sizes is provided for selection of a suitable mesh size. The lid (42) is detachable from the container (41) and may be releasably secured (41) by screw fit or push fit or by a screw-on collar.



The Search Division considers that the present European patent application does not comply with the requirements of unity of invention and relates to several inventions or groups of inventions, namely:

1. claims: 1, 2

The first invention discloses a liquid spraying apparatus comprising a gravity feed spray gun and a reservoir. The prior art document D1 (FR2631254) discloses an apparatus which has all the features of claim 1 (see also search report).

report).
The STF (Special Technical Features) of the first invention are considered to be the features of claim 2:
-container made of translucid material

-markings

The problem solved thereby is how to assess what volume of liquid remains in the reservoir.

2. claims: 3, 4, 26-28

The second invention discloses a spray apparatus comprising a spray gun and a container with venting means.

Same prior art document D1 discloses all the features of claim 3 and of independent method claim 26.

Its STF are considered to be the features of claim 4: a valve mechanism or a flip top closure or a re-sealable strip of tape.

The problem solved by this feature is how to let air in the reservoir for providing a proper liquid flow while ensuring that the reservoir is sealed when not in use.

3. claims: 5-8, 18-25, 30

The third invention discloses a spray apparatus comprising a spray gun and a reservoir with a filter, or a gravity feed reservoir with a filter.

Its STF is considered to be a filter.

The problem solved by this feature is how to avoid impurities to enter the spray gun.

4. claims: 9-11

The fourth invention discloses a spray apparatus comprising a spray gun, a reservoir with a lid and securing means for attaching the lid to reservoir. Its STF is considered to be: a screw fit lid The problem solved thereby is considered to be how to fasten the lid to the container and how to seal the assembly.

5. claims: 12-13, 31

The Search Division considers that the present European patent application does not comply with the requirements of unity of invention and relates to several inventions or groups of inventions, namely:

> The fifth invention discloses a spray apparatus comprising a spray gun and a reservoir with connection means. Its STF is considered to be: the outlet is shaped for attachement to the spray gun. The problem solved thereby is considered to be how to

connect the reservoir and the spray gun together.

6. claim: 14

The sixth invention discloses a spray apparatus comprising a spray gun, a reservoir with outlet sealing means. Its STF is considered to be: means for sealing the reservoir when disconnected. The problem solved thereby is considered to be how to prevent leakage when connecting/disconnecting the reservoir.

7. claim: 15

The seventh invention discloses a spray apparatus comprising a spray gun, a reservoir with disposable parts. Its STF is considered to be: diposable container and/or lid. The problem solved thereby is considered to be how to fasten the lid to the container and how to seal the assembly.

8. claims: 16, 17, 32

The eighth invention discloses a spray apparatus comprising a spray gun, a reservoir and a holder Its STF is considered to be: a holder The problem solved thereby is considered to be how to conveniently hold the reservoir for refill or for connection.

9. claim: 29

The nineth invention discloses a method for use of a spray apparatus comprising a spray gun and a reservoir. Its STF is considered to be: the step of mixing added liquid to the reservoir The problem solved thereby is considered to be how to provide a homogenous liquid composition.
