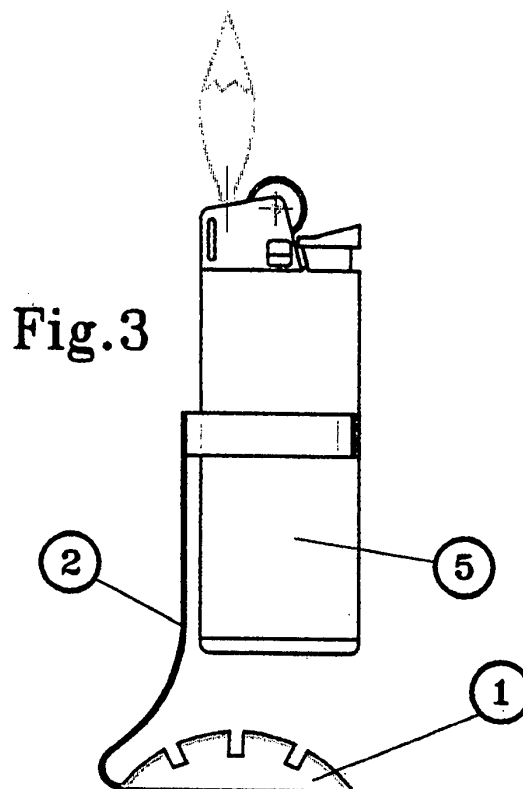

(54) **Support for cigarette lighters with function of fragrance burner**

(57) This invention consists of a support for cigarette lighters of any kind. It comprises a hollow base connected by means of a vertical element to one or more rings, where the lighter is inserted. When this support is reversed, it can be also used as fragrance burner, as the flame of the lighter passes through the openings of the reversed hollow base.
