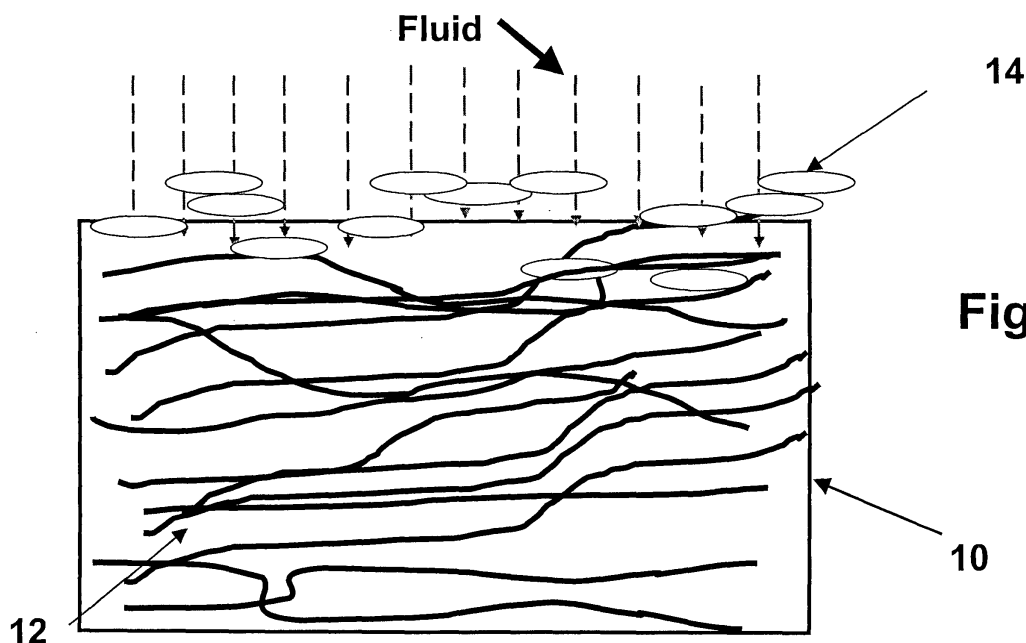

(54) **High coefficient friction material with symmetrical friction modifying particles**
