

(54) Plant for compacting and crushing scrap

(57) A plant (50) for compacting and crushing scrap comprising a compacting press (1) and a crushing mill (100), said press (1) comprises a tank (2) for receiving material to be compacted, means (5) for compacting said material when it is arranged in the tank (5), said com-

pacting means (5) being rotatably associated with said tank (2), mobile between a first receiving position and a second compacting position of the material inside the tank (2), means (16) for pushing the material after compacting from the tank (2) to the press (1) through a transfer channel (200) placed between them.
