least one upright wall surface, wherein at least one wall surface is covered with braiding on the outer side, which braiding comprises paper.

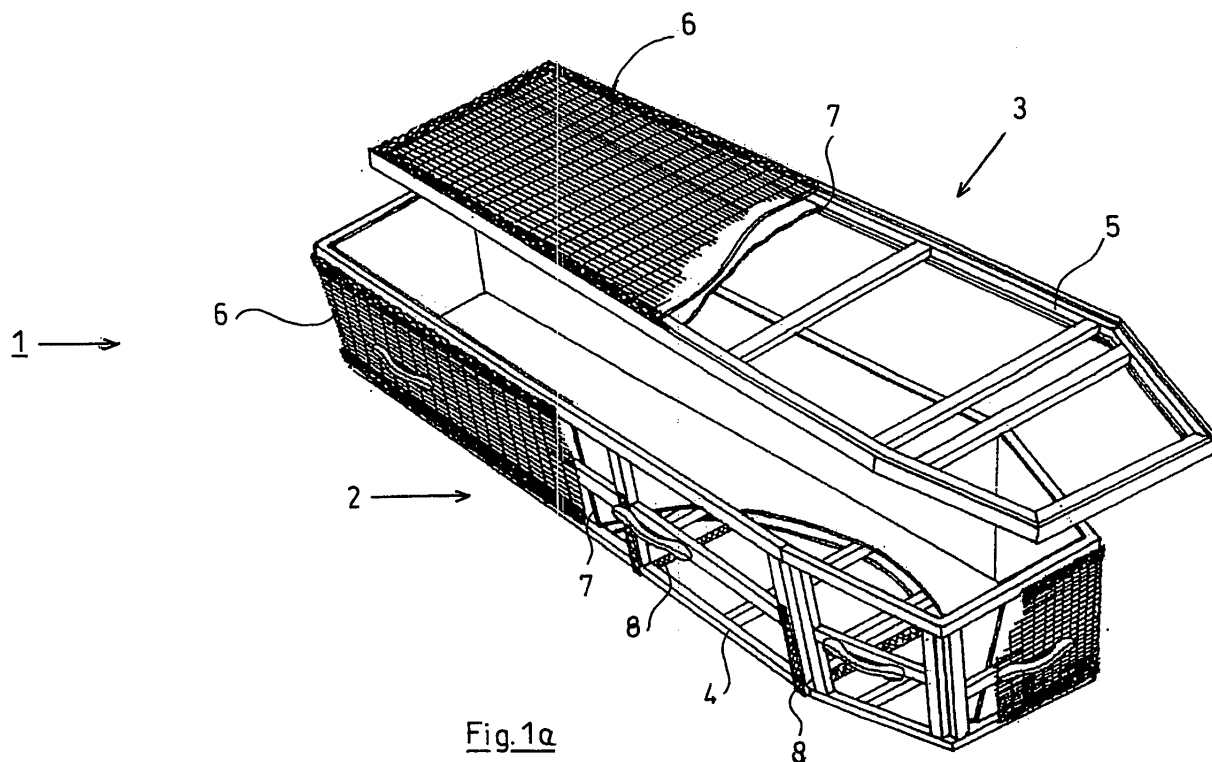
