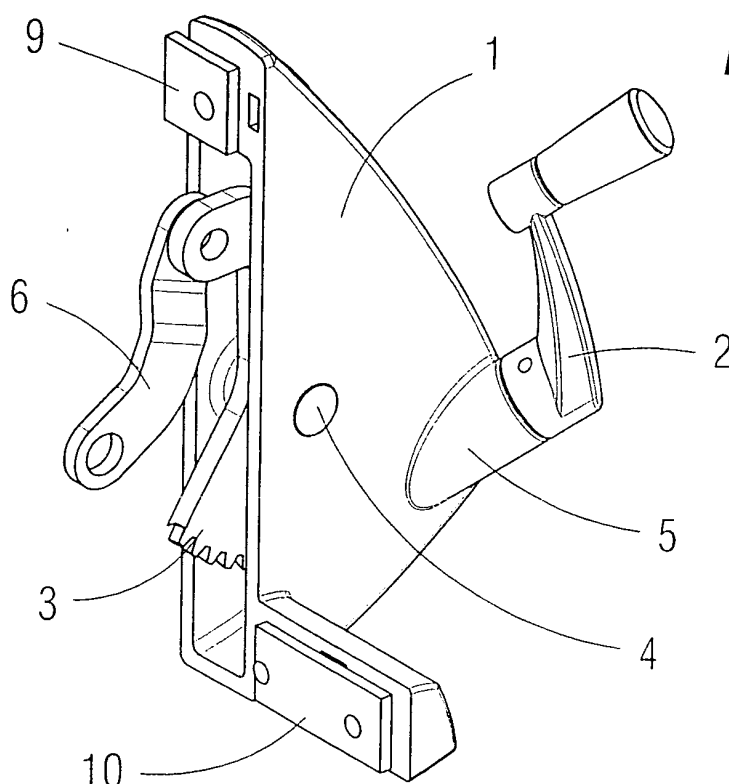

(54) **Window opening and closing device**
