

(54) **Apparatus, assembly and method for the support of formwork for storey floors.**

(57) Device for the support of concrete slab formwork, wherein the device comprises at least one joist for the horizontal support of the formwork, and wherein the at least one joist is assembled with girders to form a

framework. It is further preferred for at least one of the girders to be removable. The device is provided with fastening means for fastening the girders to the walls that support the floor.
