

### (54) A bag storing and carrying shoes

(57) There is provided a bag storing and carrying shoe(s) (1), the arrangement of which comprises at least one cavity or compartment (8,9) to receive independently

a shoe, preferably in pair of cavities or compartments to receive independently each of pair of shoes (15), with the cavity or compartment defined by an apertured enclosure wall.
