least an annular element (23) able to be disposed to cover an uncovered segment (14a) of the attachment shank (14) next to the body (13).

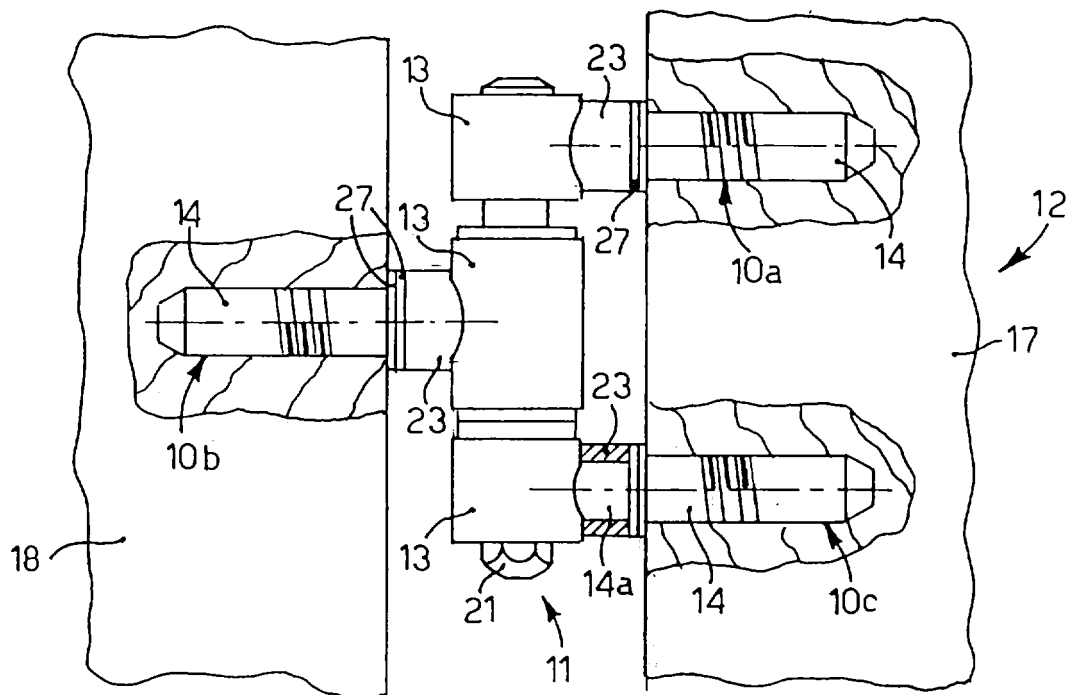
