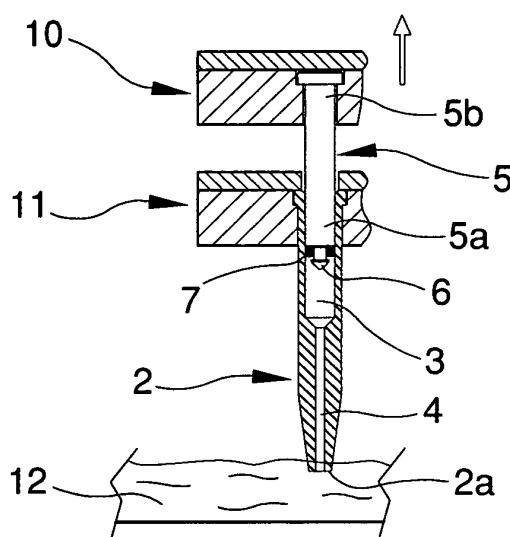

(54) **An injector for viscous fluids**

(57) An injector for viscous fluids, comprising: a hollow body (2), provided with an internal chamber (3) for containing a determined quantity of fluid, and an injection hole (4), which places the internal chamber (3) in connection with the outside of the hollow body (2); a piston (5), sealedly mobile in the internal chamber (3), between

a first position, in which the internal chamber assumes a first volume, and a second position, in which the internal chamber assumes a second volume, which is smaller than the first volume. The piston (5) is predisposed to assume a third position in which the internal chamber (3) assumes a smaller volume with respect to the volume assumed thereby in the second position of the piston (5).
