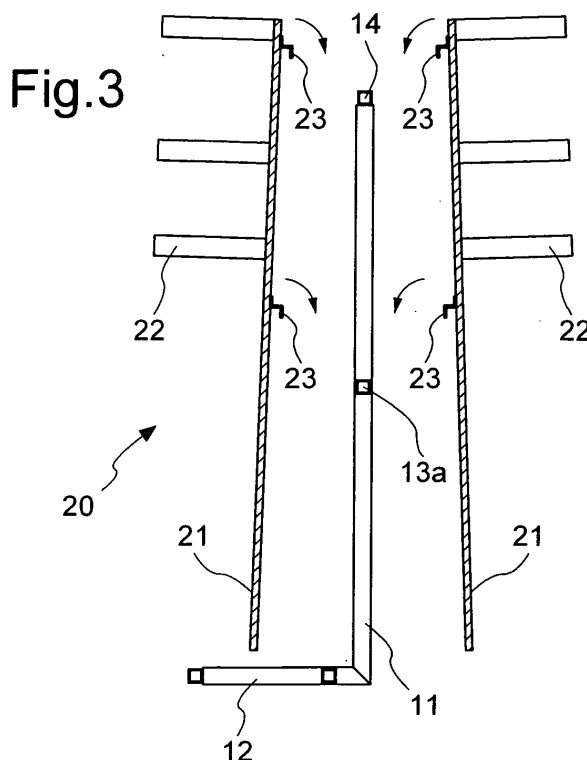

(54) **Modular self-standing support structure for furnishing components**

(57) Modular self-standing support structure for furnishing components, comprising at least one frame (10; 110) formed by a pair of uprights (11;111) provided with a respective foot (12;112) and connected together in the

transverse direction by transverse tie-pieces (13) and at least one panel (20) provided with members (23) engaging with the said frame (10;110) for covering thereof, members (22) for supporting shelves (30) or the like being fixed to the said panel (20).
