### (54) Attachment and support means for a collapsible laundry drying rack and laundry drying rack

(57) The present invention relates to an attachment and support means for at least one grid (2) of a collapsible laundry drying rack, which comprises at least one magnetic insert designed to hold the grid, and a collapsible laundry drying rack provided with at least one grid and at least one upright, in which the said grid is held in position with respect to the said upright by means of an attachment and support means (3,30) of magnetic type.


