for attaching the mattress releasably to the bed base. It also relates to a bed provided with a system according to above.

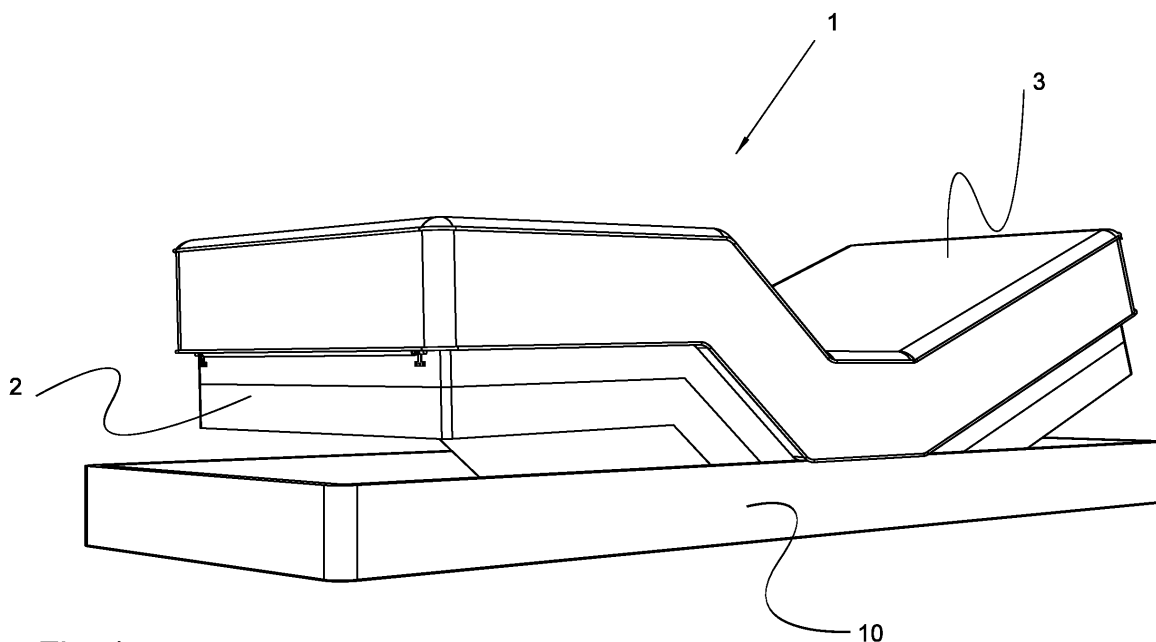
