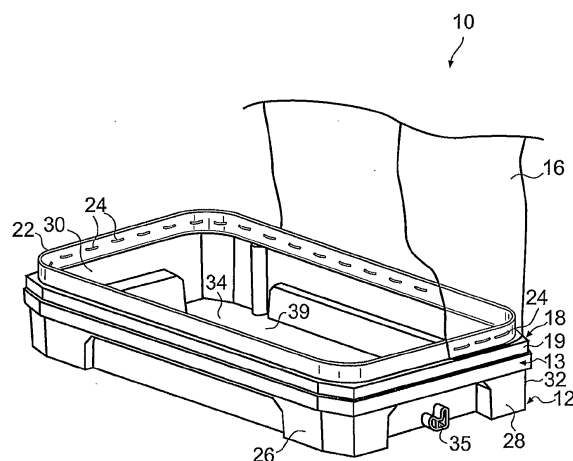

(54) **Multi-Material Connection and Carrier Assembly using the same**

(57) A partially rigid and partially fabric assembly including a rigid structure having first connector elements, fabric material for being connected to the rigid structure, and a plastic connector structure that connects the fabric material to the rigid structure. The plastic connector structure includes second connector elements constructed and arranged to connect the plastic connector structure to the rigid structure and a fabric connector portion. The partially rigid and partially fabric assembly also includes a sewing material sewn through the fabric connector portion of the plastic connector structure and the fabric material.
