

(54) Tool storage bag and tool storage bag set

(57) The purpose of the present invention is to provide a tool storage bag (20) and tool storage bag set having versatility and to reduce manufacturing cost. The tool storage bag (20) includes an inner tray (1) that is disposed inside the tool storage bag (20) and is in a shape of a box with a bottom and an open top to store a power

tool. The inner tray (1) is made of a fabric material. The inner tray (1) is detachably disposed inside the tool storage bag (20) where an outer surface of the inner tray (1) is supported by an inner surface of the tool storage bag (20), or is detachably disposed with a positioning unit provided between the inner surface of the tool storage bag (20) and the outer surface of the inner tray (1).
