A clamp is provided for clamping the protector and cables together.

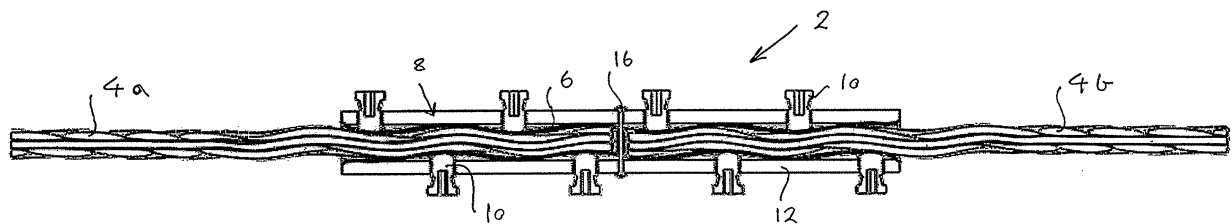
