

(54) Refrigerator having ice maker with flexible ice mold and method for harvesting ice

(57) A household refrigerator includes an ice maker. The ice maker has an ice mold. The ice mold is made from a thin flexible material, such as stamped aluminum. The ice mold includes ice forming compartments and a rotatable member with fingers for removing ice pieces from the ice compartments as the rotatable member is rotated. The rotatable member also includes a cam projection that contacts and flexes the ice mold as the rotatable member is rotated to at least partially break a bond between the ice pieces and the ice forming compartments.
