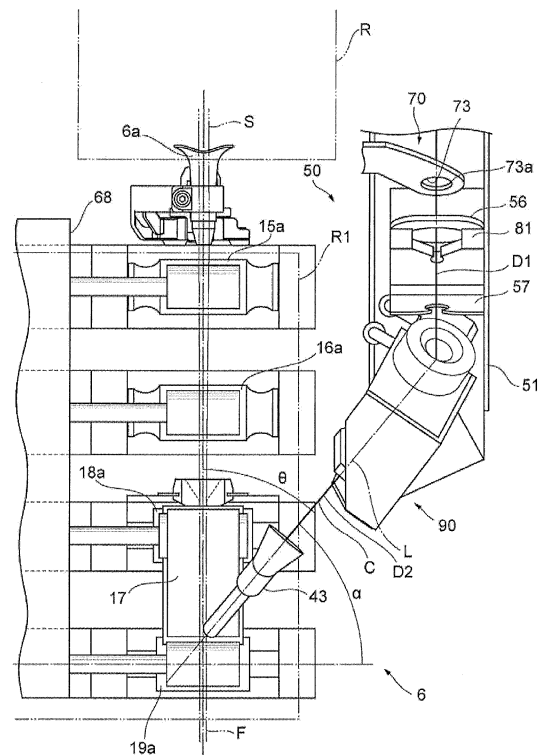

(54) **CORE YARN SUPPLYING UNIT, CORE YARN SUPPLYING DEVICE, AND SPINNING MACHINE**

(57) A core yarn supplying unit (50) adapted to supply a core yarn (c) includes a tension applying section (60) adapted to apply a tension to the core yarn (C); and a core yarn feeding section (90) adapted to feed the core yarn (C) towards a front top roller 19a, wherein a feeding path of the core yarn (C) in the core yarn feeding section (90) is arranged on a straight line connecting an inlet region and an outlet region of the feeding path.
