(54) **VISCOELASTIC FOAM PRODUCT WITH INSERTS**

(57) The current invention concerns a foam article such as a mattress or a cushion, comprising a viscoelastic foam layer, said viscoelastic foam layer has foam inserts embedded therein which elongate in the transverse direction of said article and which provide support to the body.

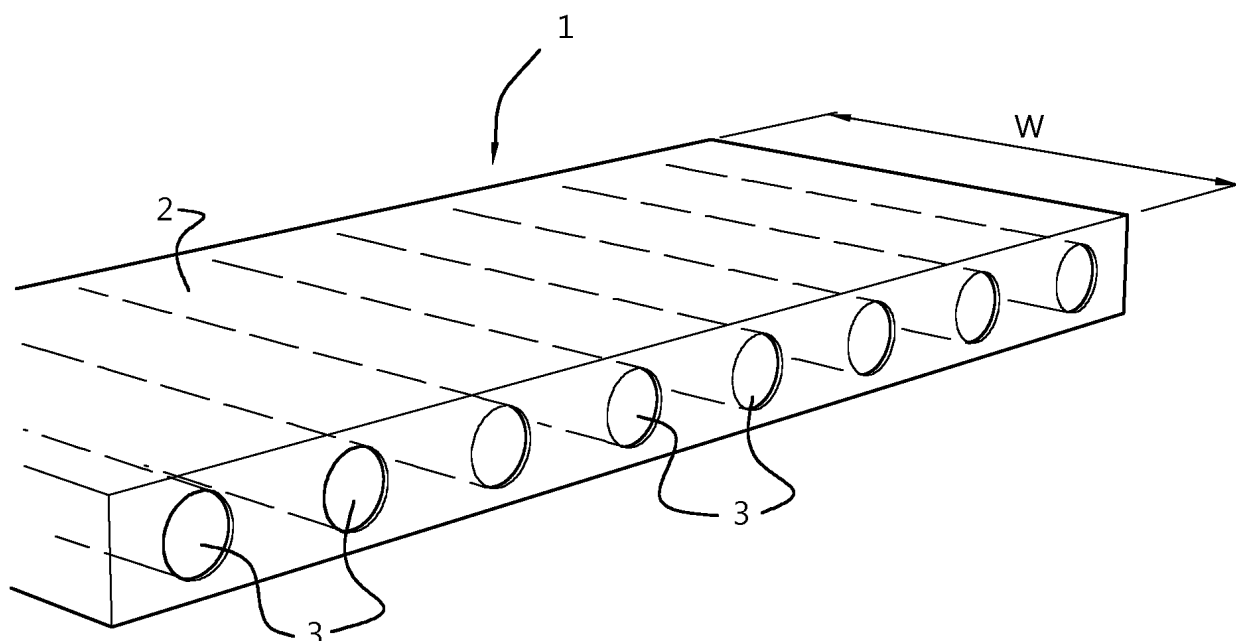
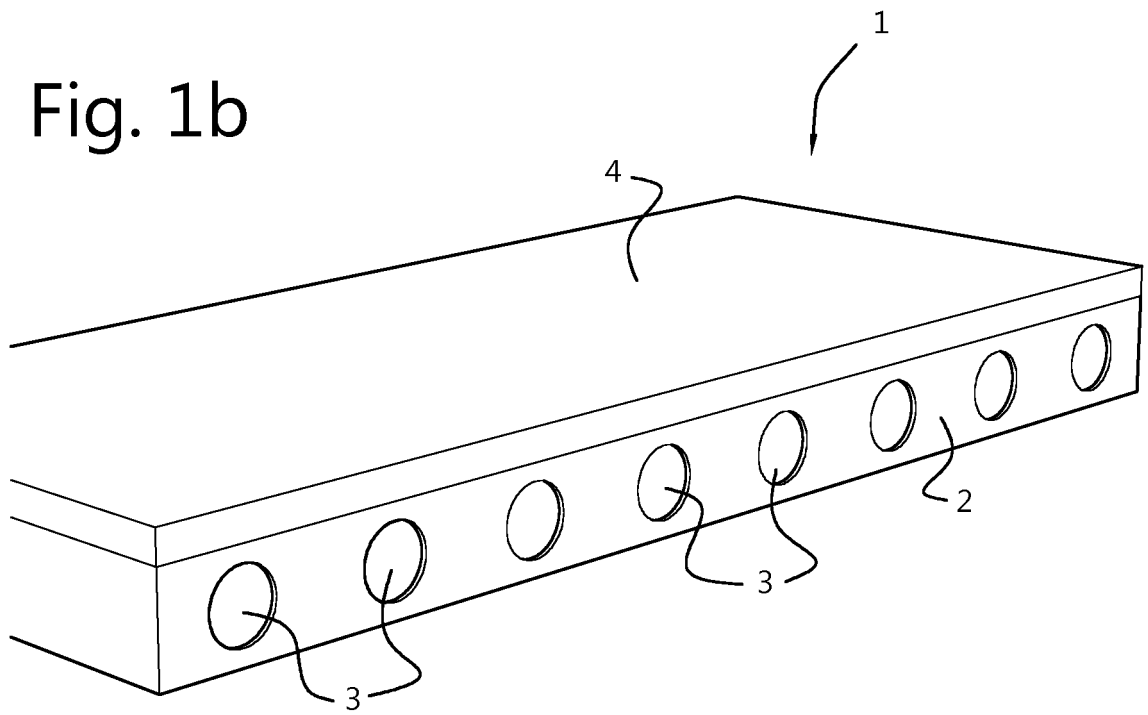
