

#### (54) REFRIGERATOR AND METHOD FOR CONTROLLING A REFRIGERATOR

(57)A refrigerator (10) and a method for controlling a refrigerator (10), including a plurality of compressors (111, 115) and a plurality of evaporators (150, 160) disposed on inlet-sides of the plurality of compressors (111, 115) to supply cool air to a refrigerating compartment (R) and a freezing compartment (F) includes determining whether a temperature of the refrigerating compartment (R) belongs to a refrigerating compartment satisfaction range  $((T_0-\Delta T_1)$  to  $(T_0+\Delta T_1))$ , determining an indoor temperature when the temperature of the refrigerating compartment (R) does not belong to the refrigerating compartment satisfaction range ( $(T_0-\Delta T_1)$  to  $(T_0+\Delta T_1)$ ), and determining whether a load corresponding operation condition is satisfied when the determined indoor temperature belongs to a set range. When the load corresponding operation condition is satisfied, a simultaneous operation of the refrigerating compartment (R) and the freezing compartment (F) is performed, and when the load corresponding operation condition is not satisfied, a cooling operation of the refrigerating compartment (R) is performed.
