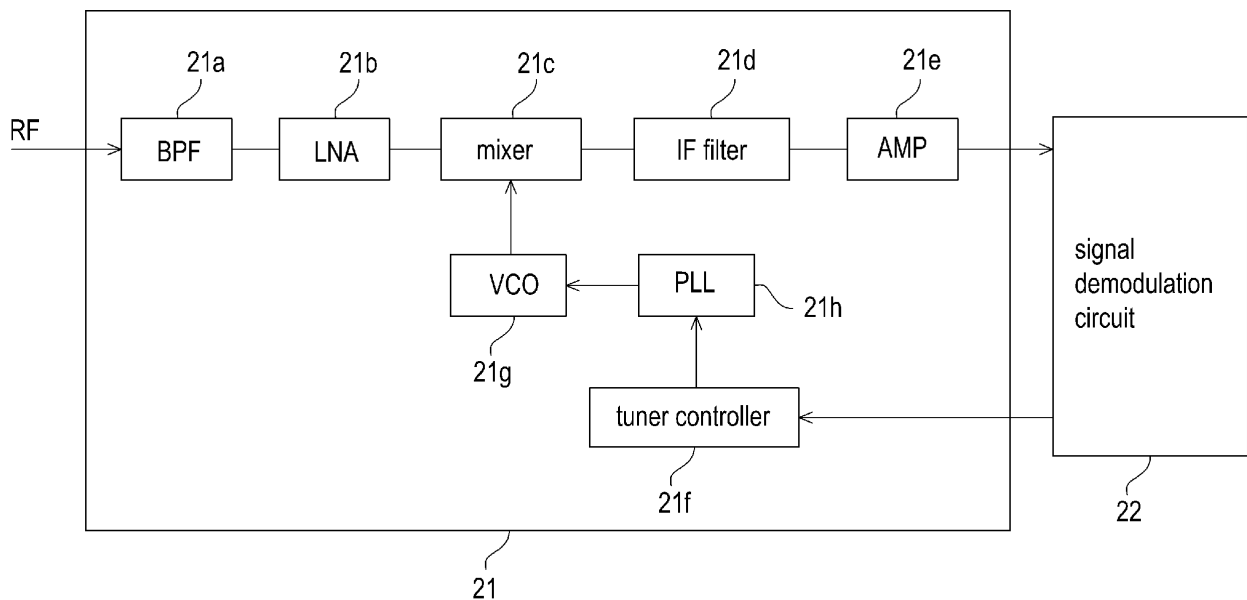

(54) **RECEIVING DEVICE**

(57) The disclosure provides a receiving device (21), receiving broadcasts. The receiving device (21) has a frequency setting part (14, 21g, 21f), setting a high-side

local oscillating frequency or a low-side local oscillating frequency with respect to predetermined receiving frequency bands to be received.
