

## (54) LABEL FOR PREVENTING FRAUD IN VEHICLES

(57) A vehicle comprising a cabin, one or more engines, a controller configured to control the engine(s) and a communication interface to the controller, the vehicle further comprising an adhesive label (20) covering at

least a portion of the communication interface. The adhesive label (20) is of a type from which it is visible if it has been removed and replaced or attempted removed.
