(54) **MICROSPHERES FOR EXTENDED RELEASE OF FENOFIBRATE**

(57) The invention relates to biodegradable microspheres for extended release of fenofibrate, injectable formulations comprising said microspheres and their use for the treatment of joint related disorders, such as osteoarthritis. The invention furthermore relates to a method of preparing said microspheres.
