

(54) **FIREARM**

(57) A firearm comprising an upper receiver, a lower receiver, a bolt guide, and a locking pin. The upper receiver may be selectively couplable to the lower receiver via at least one takedown pin. The at least one takedown pin may be selectively moveable between an engaged position and a disengaged position. In the engaged position the at least one takedown pin may couple the upper

receiver to the lower receiver. The bolt guide may be configured to be received by a bore of the upper receiver. The locking pin may be operably disposed between the bolt guide and the at least one takedown pin. The locking pin may be selectively moveable between a locking position and passive position via rotation of the bolt guide.
